2022–2023 ANNUAL REPORT

2022–2023 Highlights

Del Oro Caregiver Resource Center and our Statewide System of California Caregiver Resource Centers were moved from the California Department of Health Care Services to the California Department of Aging through legislation.

Received additional funding through the Agency on Aging, Area 4 through the Title III-E Family Caregiver Support Program, Older Adults Recovery and Resilience (OARR) funding for Placer, Sacramento, and Yolo County for Caregiver Support and Respite Care.

September 2022 Cruise Around the World Fundraiser raised \$41,650, our first in-person event post-COVID.

Our Statewide System of California Caregiver Resource Centers is providing a robust menu of monthly education and training classes for family caregivers online in a variety of languages, https://www.caregivercalifornia.org/event.

On Big Day of Giving, May 4, 2023, we raised \$14,898 from 101 unique donors.

We increased our team of Family Consultants working directly with clients to 10, thereby reducing our wait time for new appointments from 22 weeks to a few days.

OUR MISSION

Our mission is to improve the well-being of family caregivers throughout their journey.

GUIDING PRINCIPALS

The Family Caregiver is the Client
The family caregiver is provided assistance
and support, through a comprehensive
package of services designed to enable
families to keep their loved ones at home
for as long as possible.

Family Caregivers are the Care
Managers for their Loved Ones
Families participate in planning and service delivery and retain maximum control over care planning and decision making. In Placer and Sacramento Counties, we received funding from Agency on Aging, Area 4 to provide Case Management services to family caregivers caring for someone 60 years of age, or older, regardless of diagnosis.

Broad Focus across all Adult-Onset
Brain Impairments
Families face similar needs and caregiving issues across diagnostic categories.

Programs and Services

Information and Referral:

Toll-free phone line available to those desiring information regarding impairment with referral to community resources.

Family Consultation/Case Management:

Assist caregivers in understanding the disease process, developing a plan of care, and accessing a support system.

Family Counseling:

Short term counseling with referral to local resources and professionals serving family members.

Respite Care:

Time limited substitute care to alleviate caregiver stress. Available through contracted vendors.

Legal/Financial Consultation:

One-time consultation provided by an attorney (community property, estate planning, etc.).

Education and Training:

Coordination of training and other professional educational programs in subjects related to research, diagnosis, behavioral management, stress reduction, etc.

Support Groups:

Referrals to existing support groups; assistance in establishing needed support groups.

LAST FISCAL YEAR, DEL ORO CAREGIVER RESOURCE CENTER PROVIDED THE FOLLOWING SERVICES:

- 11,038 hours of family consultation with 1,447 family caregivers
- Over 1,048 hours of Case
 Management to 143 family caregivers
- 30,257 hours of respite to 570 family caregivers
- Education and training to 1,767 family caregivers
- Legal Consultation to 17 family caregivers
- 99 hours of Counseling with Licensed Therapists to 19 family caregivers

Our Foundational Roots

IN 1984, the Comprehensive Act for Family Caregivers of Brain-Impaired Adults became law, due in large part to avid advocacy of unpaid family caregivers in the San Francisco Bay Area. This legislation established the California Caregiver Resource Center (CRC) system that today represents roughly 5.5 million people. Since 1987, Del Oro Caregiver Resource Center has served as the greater Sacramento region's local CRC, carrying out our mission to improve the well-being of family caregivers through various services designed to support the physical and mental health of those caring for another vulnerable adult.
